#### A New Testament command

You ought to know how tithing is COMMANDED in the NEW Testament also - even though some liberals try to twist the Scriptures of the Holy GOD so they can GET and never GIVE. Speaking of the Old Testament Levitical priest-hood, we read in Hebrews: "And verily they that are of the sons of Levi, who receive the office of the priesthood, have a commandment to take tithes of the people according to the law .

"But he whose descent is not counted from them received tithes of Abraham, and blessed him that had the promises . And as I may so say, Levi also, who receiveth tithes, PAID tithes in Abraham" (Hebrews 7:5-9). (Tithing in not a matter of taking pity on poor God and GIVING Him alms and charity in the form of tithes and offerings - IF YOU FELL LIKE IT. IT IS A MATTER OF PAYING to God WHAT YOU OWE AND ARE COMMANDED TO PAY.)

Neglect or refusal to PAY is STEALING from GOD - cutting yourself off from the lavish BLESSINGS He promises to faithful tithers as quoted above.

But continue in Hebrews 7: "For the priesthood being CHANGED [not abolished, but a change in which priesthood receives your tithes, under the NEW TESTAMENTI there is made of necessity a change also of the law" (verse 12). What law is it talking about? As quoted above, a law in which the priesthood "have a COMMANDMENT to take tithes of the people, ACCORDING TO THE LAW" (verse 5).

The priesthood was changed at the founding of the New Testament Church back again to the Melchisedec priesthood under CHRIST. There is therefore a CHANGE in the TITHING LAW that COMMANDS YOU AND ME TO PAY TITHES TO THE MINISTRY OF JESUS CHRIST, since Christ is now our High Priest at the right hand of GOD! (All above quoted from Hebrews 7.)

#### Stealing from God

Brethren, it is not easy for me to write to you whom I dearly LOVE, and tell you that some of YOU ARE THIEVES breaking God's holy commandments, and stealing from GOD — which surely is far worse than holding up and stealing from a bank!

The living JESUS CHRIST put TITHING in God's Church from the very beginning of this Philadelphia era, and it has been in God's Church EVER SINCE A.D. 31.

Heretofore I have made NO EF-FORT TO CHECK OUR COMPUTER RECORDS TO FIND OUT WHO TITHES. I surely never wanted to "snoop." But it is a LAW! Neglect or refusal is MAJOR SIN!

I am not pussyfooting! Commandment breakers won't get into the Kingdom of God, and I am commissioned to blot out the spots and iron out the wrinkles (Ephesians 5:27) to make God's Church READY when He comes (Revelation 19:7)

# Pope's trip ushers in new era

PASADENA - Excitement surounding the election in Brussels was high, as I waited in the pressroom of the Common Market headquarters June 11 while results of the first directly elected European parliament were tallied. But community officials were disappointed for two basic reasons

First, the turnout was, in their view, "disappointingly low." Apathy combined with significant voter antipcombined with significant voter antip-athy was the rule in much of Britain and Denmark — the latter electing five *unit*-Common Market represen-tatives. Officials in West Germany — the Common Market's most enthusiastic supporter — hoped for at least an 80 percent turnout but had to settle for 15 percent less.

The second and most detracting factor in the Euro-election was that the old bugaboo of nationalism refused to recede into the background. In fact, national politics seemed to dominate the conduct of the elections.

The Daily Telegraph ran an article June 17 stating that the European elections were bound to radically alter the future of the Common Mar-ket. That is hard to see at this juncture. Political control of the com-munity will still reside largely in the hands of the EEC's Council of Ministers, who directly report to their respective national governments.

#### Platform for Dr. von Hapsburg?

Still, it would be premature to dismiss the expanded Euro-parliament as having no influence Voters, for the first time having a di-rect stake in its makeup, will expect it to be more than a rubber stamp.

But perhaps the most important role the body will have will be to serve as a platform for the views of its members. One of the most controversial delegates is certain to be Otto von Hapsburg, son of the last emperor of the Austro-Hungarian empire.

For years Dr. von Hapsburg has tirelessly campaigned for the ideal of a united Europe. He became a West German citizen last year, primarily to qualify for election to the European parliament (Austria is not member), and is expected to carry his theme forward into the parliament's two chambers in Strasbourg and Luxembourg. Dr. von Hapsburg also has a much

broader perspective of what Europe should become in the future. He told interviewers for the West German magazine Der Spiegel that if one aspires to be a Europarliamentarian, he should "stand up for all Europe," adding that "the Europe of the nine is merely a starting point. Just like the Italian unification in the 19th century started with part of a state. Piedmont, so shall the greater Europe evolve later from this Europe of the nine

Asked by Der Spiegel how far "his Europe" extends, Dr. von Hapsburg answered, "It extends to the borders of Russia" - meaning also what is today Soviet-occupied Eastern meaning also what is Furone

#### Pope calls for spiritual unity

It was in Poland, however, just preceding the main voting for the Euro-parliament, and before the highly publicized SALT II summit in Vienna, which this reporter at-tended, that the really big news was made

From June 2 through 10 the dynamic new head of the Roman Catholic Church made a precedent-shattering pilgrimage back to his homeland in Poland, one of the Communist-bloc countries. Altogether, at least six million Poles assembled en masse at various stops along the pope's nine day tour to applaud his triumphal re-

The enthusiastic throngs heard the former archbishop of Krakow call for the "spiritual unity of Europe." He issued a bold challenge to the legitimacy of Communist governments from the Baltic to the Black Sea.

The significance of the pope's performance was not lost on some newsmen. New York *Times* columnist James Reston, writing on the eve of the SALT II summit, said:

"In a mocking question about the pope near the end of World War II, Joseph Stalin asked, 'How many divisions does he have?' Now, after the rapturous reception of Pope John Paul II in Poland, Brezhnev knows the answer: 'Quite a few!' . . . More than Stalin or any of his successors imagined and more than they had to think about when the Carter-Brezhnev summit was originally planned.

On this historic trip the pope of-fered a vision of the future and

derbolt words on one occasion: 'Europe, despite its present and long-lasting divisions of regimes. ideologies and economic and peliti-cal systems, cannot cease to seek its fundamental unity [and] must turn to Christianity. "Despite the different traditions

that exist in the territory of Europe between its Eastern part and its Western part, there lives in each of them the same Christianity Christianity must commit itself anew to the formation of the spiritual unity of Europe. Economic and political reasons cannot do it. We must go deeper.

The pope is saying in no uncertain words that neither politics nor economics alone can unite Europe In fact, the two differing political and economic systems are keeping Europe divided today

#### Vatican's "good offices"

With God-given insight, Herbert W. Armstrong wrote in the October, 1951, Plain Truth:

The pope alone can provide the leadership, the unifying, solidifying element to make this United States of Europe — this resurrected Roman Empire — a reality."

And in the January, 1979, Plain And in the January, 1979, Plain Truth, before Pope John Paul em-barked on his precedent-shattering trip to Poland, Mr. Armstrong wrote: "The nations of Europe have been

striving to become reunited. They desire a common currency, a single combined military force, a single united government. They have made a start in the Common Market. They are now working toward a commor currency. Yet, on a purely political basis, they have been totally unable to unite. "In only one way can this resur-

rected Holy Roman Empire be brought to fruition — by the 'good offices' of the Vatican, uniting church and state once again, with the Vatican astride and ruling (Revelation 17:1-5).

It is plain now - to those who have eyes to see - that the soon coming resurrection of the Roman Empire will indeed comprise a church-and-state union. In one sense Joseph Stalin was correct. The pope does not have "divisions," but he has millions of people. Their organi zation into operable divisions will have to be the function of state authority

Similarly, secular rulers cannot be effective, as the Communist leaders of the Eastern Europe graphically

Daily Telegraph June 21: "Nobody would have believed it possible until this year that Herr Franz Josef Strauss would make such a come-back. His Bavarian political base seemed too narrow, his right-wing political views too provocative, to allow his nomination for the federal chancellory

As we go to press, the CDU/CSU parliamentary caucus has just selected Mr. Strauss as its candidate.

Given a sharp downturn in the West German economy, as a result of the world oil crisis, and the West Germans just might turn away from Helmut Schmidt to Mr. Strauss in droves

State of the spectrum of the



This issue's "Forum" is the result of a question-andanswer session held by Stanley R. Rader, the Work's treasurer and general counsel to Herbert W. Armstrong, in Pasadena June 15. Mr. Rader's comments cover various aspects of the present state of the Church.

A couple questions, my basic concern is over what's been in the paper recently. One had to do with something about documents the State has. What is your situation as far as giving your own deposition? And secondly, any comments concerning the article in the L.A. "Times" concerning how papers and records [unclear], is that part of GTA's papers?

No. The question had to do with my own deposition, No. 1, and the second question had to do with the recent article in the Los Angeles [Calif.] *Times*.

To answer the second one first, I think my comments concerning the audit, which we will be completing within a few weeks, will dispel all of the questions that were raised in Russell Chandler's comments in the *Times*.

As Mr. [Jack] Kessler knows, the audit is for all practical purposes, and to get down fundamentally, it is not an audit of me, nor an audit of Mr. [Herbert] Armstrong; it is an audit of the Church, but more fundamentally becomes an audit of the system that we have here, becomes an audit of the Work, of those people who have been responsible for many years for the maintenance of the system. They have been delegated a lot of responsibility and authority to preserve our records, to preserve our assets and to see to it that the books and records record everything properly and consistent with what has transpired.

And Mr. Kessler has had full access as a Certified Public Accountant for years. And he knows, and 1 know, and others know, that he is a very fine, thorough, extremely capable auditor. And what's more, as Mr. Armstrong has said, he has God's Holy Spirit as well, and Mr. Armstrong would much prefer that Mr. Kessler would be the person continuing to do the audits for that reason

ing to do the audits for that reason. But obviously the audit becomes, in large part, an audit of his work during the last four or five years, and when the thing is over he will be totally vindicated. Which means the institution will be vindicated as well, and the individuals. And a lawsuit that Mr. Kessler has against various parties for defaming him will be for all practical purposes won. It will take time before they cave in because the y'll all have insurance companies that will be rushing to their defense to try to keep the damages down. But believe me, he will recover very substantial damages for the attack upon him.

In my own case, I think you ought to understand my situation vis-a-vis my deposition. I have tried for years, singularly, to do one thing, which has been to protect this Work, and to protect Mr. Herbert W. Armstrong as Christ's apostle, and anybody else who needed protection.

As Mr. Armstrong has tried to inform you, Garner Ted Armstrong only had one other supporter in this organization from 1971 forward, and that person is standing here before you. Every other person of any standing in the ministry tried, on more than one occasion, to kick him out of this organization, and for good. Now I have assiduously done everything I could in my power to defend this Work.

And on several occasions when I was not exactly feeling in the best mood, I reminded Mr. Armstrong from time to time that if Ted didn't stop misbehaving, I was not forever . going to keep my silence. That if I had to, to defend myself, if the chips were down, I would have to do what I had avoided so carefully for so many years, and that is to make any comment that was nonsupportive, and to reveal intimate details about his son and what went on here for a period of more than I0 years.

Now if I speak, or am compelled to speak, Ted Armstrong couldn't get 10 people into a room — not into a room where 'people are thinking they' re speaking of a man of God. He may be anything else, but if I'm forced to testify, there'll be no doubt as to who he is, what he has been. Now I have wanted to testify. Iac-

tably showed up at my deposition, and I did not fail to answer any question except upon the advice of counsel who were concerned about only one thing, which was would any of my answers hurt the institution?

They tried to get — it's a matter of record — from the attorney general a stipulation that any questions I might answer would not be considered as a waiver of any of the Church's or the other corporation's First Amendment rights, and they refused to stipulate. Do you follow that? If I'm being asked a question, I'm both an individual and I'm an officer and I'm a director. If I let down that bar just a Jittle bit, then maybe I will have waived the First Amendment guarantees, which are the essence of this lawsuit. And they wouldn't stipulate to that, and that's the basic issue that we're talking about.

we're talking about. I'm prepared anytime the lawyers tell me that I should testify now, to testify, and let the chips fall where they may. I don't think that, after what I've discovered in the last week, I don't think Garner Ted Armstrong deserves one whit of my protection any longer. I will not go and volunteer the in-

I will not go and volunteer the information. I will continue to play the game according to the rules that my lawyers and the Church's lawyers have laid down for me, and that is when, and if, they think it's desirable, I will testify.

Our primary lawyers, lead lawyers, feel that I ultimately will have to testify, and should testify. And they don't want to take a chance that if I don't testify at a deposition, I would be prohibited from testifying if the case ever comes to trial, because as a repository of so much information I would be the best witness for the Church.

So we're not attempting to avoid the testimony, we're trying, pending a resolution of some of the other procedural issues, we are doing our best to defer it until we can get some relief in certain areas and certain clarification of what my testimony might mean vis-a-vis the other persons being compelled to testify.

But, believe me, I have nothing to hide. Everyone knows what my position has been on every single issue that has ever transpired in this Work of any consequence, because I had a habit of putting it all in writing.

I didn't care if I was wrong. I never tried to keep two feet in different places, on opposite sides of the fence. Whatever was necessary as part of the job that I was doing. I said it. And I said it forthrightly, frankly and one occasion vigorously to the point that it was maybe too blunt. So my advice, my counsel, my position, my activities, are well known to everybody who has any intimate knowledge in this organization. I'll stand on the record. **I have two questions. The first** 

one is, do we now have strong proof that GTA was involved with the conspiracy from the very beginning?

We now do. We now have proof that Garner Ted Armstrong was involved, yes, and his son, Mark.

And secondly, do we? Well, of course, I'd like to know what kind of proof they're talking about? We have proof. We have testimo-

nial proof from one of the people who brought the lawsuit. That's enough. He testified under oath.

Also, do we know who the mastermind who planned all this stuff up was?

I know whoever it was wasn't very masterful, was he? Then I would say we know ithat the people who are involved were the people whose names appeared, and a lawyer back in New Jersey, and a lawyer outhere, and a deputy attorney general, a corrupt judge, and an ex-judge who wanted to make a lot of money. And there you've got it. But I don't think they thought the

But I don't think they though the problem through very carefully. They relied upon a lot of information that was false, and they didn't protect themselves as to what would happen if it were false. But they were told by others, such as Wayne Cole, that there wouldn't be any resistance, that everybody wanted Mr. Armstrong out of here, and that he was holding things up.

Ron Dart has been quoted as saying, "If Mr. Armstrong had only died years ago, this Work would have been better off!" Anyone believe that in this room? That's what he'd been quoted as saying. If he'd only died years ago, what we could have accomplished again. Ron Dart. Couldn't even handle Henry Corriwall. Henry handled him all by himself, just took two letters, and he was a packing all the way to Austin [Tex.]. The power of the pen, you know,

The power of the pen, you know, particularly when it's a powerful, truthful pen; it's very strong. Two letters Mr. Cornwall sent out just getting a few facts before the people. Garner Ted Armstrong had to eliminate Ron Dart from the ministry here for all practical purposes. Sent him on sabbatical to make a precedent out of him. Sent to Austin to learn some educational courses and come back as president of Ambassador College. But for the moment to get him out of town — anything.

No, I don't think it was very masterful, but that was the conspiracy. That's what they tried to do, and they were hoisted by their own petard. In other words, they just simply didn't think the problem through.

What would happen if the information that had been coming to them from these people, what would happen if it was false? And what would happen if Mr. Armstrong wasn't some senile old fool lying down there in Tueson in a state of semiconsciousness.

That's what they were told. Mr. Armstrong didn't even know where it was all at. They found out in a hurry. His letters alone destroyed them. Every time they did something or said something, he wrote another letter.

It was a marvelous battle if you think about it. Whole power of the State, 20 million some-odd people, and Mr. Armstrong, this man who they described down there, this man he treated as a son-in-law — son, rather — calling him senile in affidavit: made every move by letter. Everything that was done, he just wrote another letter. The battle was quickly over.

But, of course, we had God and Christ protecting us too, you know, so that's that spiritual resource they didn't count on. But we have the proof now. We had suspicions before. And you remember some of you asked questions right in here, did 1 think Garner Ted Armstrong was involved? Remember that, all the way back? I said I don't know. And when I didn't know I didn't

And when I didn't know I didn't comment, did I? I said, I don't know, and I said as long as I don't know it isn't relevant. It isn't all that relevant now, it's just kind of interesting. It's kind of interesting that Wayne

It's kind of interesting that Wayne Cole is now employed by Garner Ted Armstrong and is preaching in Tyler, Tex. The highest-ranking person in the ministry a year ago, who had come to Mr. Armstrong with all of the support he could muster and with as much power and authority as he could, let's say, collect of himself, to make the presentation, urged that Mr. Ted Armstrong be thrown out of this Work, for a variety of reasons, in writing and again, and again, and again orally. How do you account for them being together now? So that's just curious, that's all.

Mr. Rader, this is concerning the great commission, which we're doing. What are our plans now for getting out the printed word in these countries where Mr. Armstrong has visited? Are we going to continue to try to approach it with the printed word, say by "The Plain Truth" or by literature? Or are we going to try to follow up with, in terms of radio or TV?

We just made our first visit to North Africa, as you know, and it's French speaking. And we have a viable French *Plain Truth*, and I think we can see that it's circulated there. And I think that we can do some good work there.

We'll also work through the foundation, as I think I mentioned in *The Worldwide News*. We're going to work in the area of nutrition. And Mr. Dale Schurter, by coincidence, on his own has arranged for his own speaking engagement in Algiers [Algerai] on the same subject very soon. So we'll be catching a lot of attention in that area and have already made a fairly powerful impact.

In the meantime, Mr. Armstrong will be working, and now with the new format as much as possible, for television in this country and for presentation in Canada. We're doing everything we can to make him as satisfied with the makeup of *The Plain Truth* so that it becomes, as he has wanted it to be, the most powerful printed medium for the fulfillment of the great commission.

And once the domestic and Canadian version have been brough into a position where he is totally satisfied, then we will turn our attention to being certain that the foreign editions are doing their job.

I have confidence that Mr. [Frank] Brown in London — He's concerned about what *The Plain Truth* is doing and has been doing in London for the English Work. He feels he has some definite ideas, and he wants to present them to Mr. Armströng at the proper time, about what *The Plain Truth* could be and what it could do in England.

And the same would probably be true of the people in the other offices. But Mr. [Brian] Knowles is working as hard as he can to bring about for *The Plain Truth* what Mr. Armstrong is going to put his stamp of endorsement on.

#### I think the concern that I'm expressing here would be diversity of languages and the problem, we have with illiteracy, because there are a lot of people who can't read "The Plain Truth."

They also don't have radios, and they don't have television sets, so we don't really expect to convert that many people in the Moslem world, even if we were called upon to save souls.

We have a commission, however, that tells us we have to get the announcement out, and we've always felt that *The Plain Truth* is the vehicle for the printed words, the vehicle that is going to bring to the attention of the people, with the most impact, what our message is all about

And those people are very literate. They speak English, they speak French. They speak other languages, although French is their primary tongue. And as a consequence, when we were there I had the unique experience of giving my first speech in French, and before about 150 of the country's leading people, including the minister of culture and the minister of education and the minister of the cabinet: and so on

So I did give my address in French because that is their tongue. But I would say that for those, and remember, they have a lot of Catholics in those countries because the French were there, and some of those people may very well heed our message even more so than in some of the other countries.

I think we've dealt with the question of illiteracy satisfactorily in places like the Philippines, where you have a large degree of illiterate people, and yet our English Plain Truth has done well there, and the Church has been growing. So eventually we'll turn that problem completely over to Mr. [Dibar]Apartian. I'm sure that he'll do a great job in seeing to it that the magazine and the other literature that he has, gets into the right hands.

We were well received, though, and Mr. Armstrong thought it was an immiensely successful trip, and it was our first foray into that area. **Regarding [unclear], I was won-**

Megarding [unclear], I was wondering what is the possibility, in the future, of having our literature, "The Plain Truth," printed in, let's say the Portuguese language, the Italian, the Japanese language or any other language that it isn't being printed in.

We've taked a long time about getting the magazine printed into the Arabic language and also Japanese language. And we've made some abortive efforts in that direction over the years, but I don't know what the plans are at this time.

I think, as I said before, it's largely a question of budget. Once we get our priorities structured in the best possible fashion and we begin to have a vertical growth curve, I think it's quite possible that we would have both Japanese and Arabic.

Although I would think there would be much more chance of having a larger readership in the Japanese language than in the Arabic language, because of the literacy factor, and the fact that the Moslems are pretty deeply entrenched and have been for 1,300 years.

Japanese embrace all religions rather nicely, they're very tolerant, and they're always willing to try something new. So maybe they'll find that we're not only new, but that we're the only true Gospel. But their attitude toward things religious is quite different from any other place in the world.

I told you about the time that we were in Nepal and we were politely, but firmly, warned by the chief justice of the supreme court who was present that evening at the banquet, along with the prime minister and other dignitaries, that there was an archaic statute, but it was still on the books, that anybody who was found guilty of causing someone to convert from Buddhism to a different religion would suffer a mandatory 14-year jail term.

So I cautioned Mr. Armstrong to be very careful, and fortunately that particular banquet went on and on and on, and by the time it came for him to speak he decided to say very little. It might have been quite awkward. I don't think the justice would have said that to me if there weren't something that was concerning him. And that wouldn't be a very nice (See FORUM, page 5)

Seven Caribbean Festival sites offer tropical setting, activities

By Stan Bass SAN JUAN, Puerto Rico - The Feast will take place in seven English-language sites in the Caribbean islands — the Bahamas, Bar-bados, Bermuda, Guyana, Jamaica, Puerto Rico and Trinidad-Tobago. Services at all these sites will be con ducted in English, with Spanish translation at Puerto Rico. The climate in all of the islands is

subtropical with cooling easterly breezes. The climate in Guyana, situated on the northeastern corner of South America, is a little warmer than that of the islands of the Caribbean. Individual Feast site information is as follows:

#### Bahamas

We will again be holding the Feast at the Holiday Inn, Paradise Island, Nassau, about 180 miles from Grand Bahama Island.

The typical housing package deal this year runs \$384 a person, single; \$214 a person, double; \$179 a per-son, triple; including an air conditioned room for the eight nights, tax and gratuities. This does not in-clude meals. In order to hold the Feast at the Holiday Inn, we must ask you to permit us to make your reservations

Snorkeling, fishing, hiking, swimming and horseback riding are some of the activities available.

No transportation will be needed at the Feast site, as the meetings will be at the Holiday Inn. The airport is about seven miles from the site, and taxis and rental cars are available there. Those persons wanting to rent a car should do so through their travel agent or airline

#### Barbados

The Festival location is the Government Convention Center, St. Lawrence Gap, Christ Church, Barbados.

Swimming, snorkeling, surfing, fishing, nightclubs and horseback

riding are popular activities Hotels are within walking distance

of the Convention Center at about \$30 for a single and \$40 for a double a night. Meals, tax and tips bring expenses to about \$45 to \$50 a person a day. In Barbados you may make your own housing arrangements if you wish, but you must notify us as there is a space problem in the meeting room. It is necessary for you to go through the regular application pro-cedure, stating on your application your lodging plans and the number in our party

No transportation is needed at the Feast site if you are in a hotel nearby. However, those persons wanting to rent cars may do so at the airport, which is about five miles from the

#### Bermuda

Feast site.

The Festival location is the Sonesta Beach Hotel, Southampton. Hotels in Bermuda are expensive. Many members have found it convenient to live in guest houses, which cost approximately \$20 to \$25 a day for each person. We recommend that you allow us to make your arrange-ments in Bermuda. All accommodations are first class, minutes from the beach, with pools and air conditioning

Swimming, snorkeling, fishing horseback riding, hiking, golfing and sailing are some of the site's recreational attractions.

Generally speaking, transportation will be needed to get from your hotel or guest house to the Feast site. We will be able to arrange transporta-tion, although in Bermuda rental cars are not available. However, you may rent *mobilettes* (motor-assisted cy-cles for which no license is required) for \$7 to \$8 a day. The Feast site is about 12 miles from the airport.

#### Guyana

The Feast in Guyana will be at the Pegasus Hotel in Georgetown. Per-

sons wishing to keep the Feast here should contact their travel agent for reservations at one of the two leading hotels in Georgetown, the Pegasus or the Tower.

Guyana does not have an excessive number of quality beaches like the other Caribbean sites. The major activity is sight-seeing. Kaieteur Falls, one of the major attractions, has a sheer drop of 741 feet, making it perhaps the world's grandest waterfall. Flights can be made into the area, which is in the interior, by contacting Guyana Airways.

#### Jamaica

The Feast will take place again this year at the Runaway Bay Hotel & Golf Club, Runaway Bay, Jamaica, on the north shore Jamaica is another site where, in

order to protect the availability of the Feast site, we must ask that you allow us to make your housing arrange-ments. The rates this year are single \$34.20. double \$41.20 and triple \$55.47 for the European plan, and single \$56.20, double \$85.10 and triple \$121.47 for the modified American plan (two meals included).

Those staying at the Runaway Bay Hotel need no transportation to ser vices. However, car rentals can be made through your travel agent. The hotel is about 45 miles from the nearest airport at Montego Bay

Hiking, fishing, waterskiing, nightclubs, sight-seeing, golfing, horseback riding and swimming are popular activities.

#### **Puerto Rico**

The Festival location this year will be the Hyatt Rio Mar Resort, Palmer, at the foot of the National Rain Forest El Yunque near beautiful Luquillo Beach on the north coast.

Housing will be at the site, and we ust require that we make your ar rangements to protect the availability of the Feast site and special rates. The cost will be \$40 (European plan) a room a day, plus a 5 percent government tax added. The rooms are kitchenette units, and can accommodate up to four persons. There is also available a modified American plan at \$18 a person a day additional plus 15 percent gratuity. Other charges include 50 cents a day a person for maid service and a one-time bellman charge of \$2 a person for the stay.

Pasadena, Calif., 91123.

Those persons wanting to take advantage of Rio Mar's transportation from the airport will pay \$15 a person round trip. Please indicate on your application if you desire this service. It will not be possible to buy a one-way fare; it has to be the round trip at \$15. Transportation at the site is not needed, but if you would like to rent a car you may do so through your travel agent or airline. The Feast site is about 19 miles east of San Juan International Airport.

Swimming, fishing, nightclubs, hiking, horseback riding, tennis (\$3 to \$4 an hour a person) and golfing are popular activities at the site.

#### Trinidad-Tobago

The Festival location is the Golden Thistle Club on the island of Tobago (Robinson Crusoe's island), 21 miles off the northeast tip of Trinidad.

Because of a special group rate we need your cooperation in allowing the Church to make your housing accommodations in Tobago. The hotels available run \$22 to \$30 a person a day, including two meals, with children some \$5 to \$10 less.

Activities include sight-seeing (bird sanctuary, coral reefs, etc.), swimming, boating, hiking and snorkeling.

Accommodations are all within walking distance of the meeting hall. We will book your flight from the Port of Spain, Trinidad, airport for Oct. 4 and 5. There is no extra charge. Your airfare to Trinidad includes the flight to Tobago.

I would like to mention once again the reason for our requiring a limitation on making your own lodging ar-rangements at the Bahamas, Jamaica, Puerto Rico and Trinidad-Tobago sites. In order to obtain the meeting facility, we have to deal with the hotel on the basis of their playing host to a convention.

This makes us in essence the or-ganizers of the convention, and we must provide the guarantees for using a certain number of rooms.
